B. Charlette Angeron, 911 District Director, has writing to request a waiver to the vacation time policy of St. Mary Parish. As an emergency operations center, our hours of work are completely different from the hours worked at most other parish agencies. We operate twenty-four hours a day, seven days a week.

Our previous policy that worked well for us for many years, allowed employees to receive pay for up to eighty (80) unused vacation hours per year in lieu of time off. Since our full-time employees all have more than eighty (80) hours of vacation time, they will still be able to take needed time off, and yet reduce the burden on payroll and scheduling.
